President's Report:

John Watt gave a verbal report as is usual with a Half Yearly Meeting.

- Congratulations to Casino for running a successful NRVGA Championship in October 2016
- o NRVGA Champion 2016 John Quirk from Casino Veterans
- Veteran Open Days are going well with participation and camaraderie good at these days
- The way we conduct a Vet Open Program and subsequent Veteran Open Days is unique to NSWVGA. John congratulated all Vet Committees in organising these days
- O Highlighted a perceived problem with Iluka Vets. There have now been two meetings that there has been no representative from Iluka Veterans. Coupled with this John related his experience at Iluka Vet Open Day where a number of Clubs were not able to gain entry to the day. Also, Presentation was not good with only an extremely small number of Veterans present. Reference was not given to NRVGA Trophy Winners. John said that he had discussed this situation with Vice President John Lowe and stated that they both would travel to Iluka on one of their home Veteran Days to discuss these issues.
- Further discussion amongst the Delegates stated how Iluka used to be a vibrant participating Club at Open Days but this has now stopped. Woodburn Evans Head, Coraki and Maclean stated that they do have an Inter-Club competition with Iluka but numbers being reciprocated from Iluka are always down

 - 4BBB Championship at a Zone and/or State Level
 - Mixed Championship
 - Increased vouchers at Weeks Of Golf
 - Establishment of a Hardship Fund for struggling Veteran Clubs
 - Advertising for NSWVGA Handbook closes 30 October 2017

- With Increase forecasted for 2018, NRVGA Clubs are being put on notice that an increase in NSWVGA Fees will necessitate an INCREASE in NRVGA fees as from 01 October 2018
- Len Payne, Secretary NSWVGA asked that all Clubs and Group Associations have a succession plan, and that all Group Secretaries have an Assistant Secretary so that important information can be conveyed.
- Due to projected increase in 2018 Fees to NSWVGA, a motion regarding NRVGA Fees was put to the meeting.

- Acknowledge John Daley as NSWVGA Councillor In charge of NSWVGA Program
- ➤ Barry Maloney from Bellingen is the new Webmaster employed by NSWVGA to create and maintain NSWVGA website go to nswvga.com.au
- Kel expanded the information regarding increase to \$5.00 for NSWVGA Registration fee NSWVGA has \$40,000 in Term Deposit which is to be used in case of emergency Working funds coming in from current registration fees are expended each year

General Business:

 Ray talked about Website created for NRVGA and demonstrated how it works Members were encouraged to visit the website and explore its possibilities nrvga.com and follow the prompts

Two Motions were put -

Motion 1 ... "That NRVGA purchase Wordpress Premium Theme, Domain Registration and Mapping at a cost of \$129.00. This cost is to be paid by Webmaster when due and then be reimbursed. This will be a recurring cost to NRVGA each year (30 March)"

Moved and Seconded Ray Kent and John Lowe - CARRIED

Motion 2 ... "That NRVGA purchase Adobe Photoshop Annual Subscription. This cost in 2017 is \$275.88 and is to be purchased by Webmaster when due and will be reimbursed. This will be a recurring cost each year (Nov each year)"

Moved and Seconded Ray Kent and John Lowe – CARRIED

- Jim Kelly (life Member and Patron) spoke on behalf of Keith Ruttley and himself, as to how good it was to see the Veteran Group in such a strong position. From humble beginnings to now digitally enhanced, the NRVGA is moving forward. Jim congratulated the Executive.
- Trevor Townsend (Grafton Veteran Golf Club) spoke
 - Thanked NRVGA for accepting Grafton Vets into the Group 14
 - It will take time for Grafton Vets to "acclimatise" to the notion of belonging to an Association but progress can be made.
 - Working on strengthening the Veteran Committee. Since John Tibbs stepped down, no-one would step up. This has to change.
- Ross Lever (Coolangatta Tweed) spoke about Open Days and the rising costs of Play/Lunch and then Hiring of Cart. Put in the cost of petrol and we see a "drop" in numbers attending. These are all contributing factors to reduced numbers from some Clubs.
- WEH responded as to how they subsidise Members travelling to veteran Open Days.
- Discussion followed about NOT charging for lunch and that participants purchase their own. Jim Kelly spoke about how this was tried many, many years ago and was proved NOT to be a success. However, in this year's climate, maybe it may work.

- Keith Ruttley thanked the NRVGA for their contribution of Life member Shields to the Life Member's Home Club. These are much appreciated and promote the efforts and contribution of these Vets. Shields are rigorously contested.
