John presented his report. In essence, John praised Grafton for their inaugural Veteran Open Day held 189 June 2018; Casino for their excellent Trial Week Of Golf and the fact that they have now secured a permanent place on the Week Of Golf Calendar; Ocean Shores for running the 2017 NRVGA Championship with Fred Williams from Ocean Shores being crowned NRVGA Champion 2017; Ray Kent for his computing skills which has kept us as the most efficient group of Veterans in NSW.

John thanked our Councillor Representatives – John Daley (Yamba) and Peter Taylor (Woodenbong)

John mentioned our Constitution that has to be revisited at our AGm and encouraged discussion regarding the decision by Mullumbimby to put a limit on Club's number of entries. This would be discussed in General Business.

John thanked all Clubs and their Executives for making the Northern Rivers the place to play and enjoy relaxing golf.

Secretary's Report

Ray's report dealt with statistics from our first nine Veteran Open Days and, in particular, the percentage of Balls in the Ball Run-Down in relation to the numbers in the field. It is hoped that Clubs will look at the number of balls being handed out, especially as Clubs are charging the \$30.00 entrant fee.

Ray also stated that he would be overseas from 9 August to 29 September.

As Treasurer, Ray also gave the Interim Financial Report. Funds available - \$5361.36 and a Term Deposit of \$6000.00. Ray has also deposited into ALL remaining host Vet Open Day Clubs' Bank Account the NRVGA Trophy prize of \$50.00.

NSWVGA Councillors' Report

Both John Daley and Peter Taylor, our Northern Rivers' Councillors gave an outline of initiatives and directions of NSWVGA.

NRVGA Championships Report – Monday 19 November 2018 at Byron Bay Reg Wallis, Byron Bay, stated that everything will be ready and in place depending on the field size for this year's Championships.

General Business:

AGM in October

- John Weaver, Tournament Director Casino Week Of Golf gave a brief report on thr Trial Week Of Golf held 14-18 May. Average field each day was 65.
- Ray talked about Social Golf Clubs ... although having Golf Link Numbers, these players are not permitted to join any Veteran Organisation. (AVGU Annual Meeting 2016) as they do not belong to an affiliated Club.
- NRVGA Constitution ... This will be revisited at our AGM. In the meantime, Delegates
 are asked to download a copy of the Constitution from the NRVGA Website and note
 any changes, deletions or additions that may be warranted. The Executive will in the
 meantime look at the existing Constitution which was last ratified on 16 October
 2006.
- Ray distributed to each Club a print-out of their Membership as at 20 June 2018 and also a Statement of each Club's payment of Fees Due and Paid during the current season. All Club Secretaries were asked to check these names as each player has been registered with NSWVGA.
- Discussion took place around the decision by Mullumbimby to limit the number of entries from each Club at their Open Day. Wayne Rogers spoke and listened to the various Delegates' responses. Various scenarios were put forward. Reg Wallis reminded everyone when, some time ago, a limit was put on Clubs for Open Day Entries and that this became unmanageable and the limitation was dropped. John Lowe said that it would not be right to prevent individuals from competing as this disadvantaged those in the running for the NSWVGA Medal. ... Should we make the 4BBB Qualifying Round a separate day? Should there be a third qualifying Round at a different venue? After much discussion, Wayne stated that Clubs should get their numbers in by Monday's Closing Date and that he hoped that there would be no culling as some Clubs would not be sending any Entries.
 We will relook at this issue when determining the Year's Open Day Program at our
- Moved John Lowe and seconded John Watt, that a letter of Appreciation be forwarded to Kel Pearce for his contribution to Golf in NRVGA.
- The situation earlier in the year at Iluka that prompted the letter to be written was discussed. It was decided that this situation happened because of the demeanour and actions of just one individual and hopefully this attitude will change. On another issue discussed was the fact that Iluka has not been coming to Meetings for some time, nor had they been supporting Veteran Open Days, Some Clubs have decided that they would not be supporting Iluka Vets if they did not start reciprocating visits. it was moved Bob Harvey and Seconded John Frederiksen that the Secretary write a letter to Iluka Veterans Golf Club explaining expectations of a Member Club of the Northern Rivers.
- Discussion took place regarding Divisions for Competitions in Veteran Open Days, similar to that just held at Grafton. Delegates agreed that the Veteran Days were excellent and had no issues with the Handicapping System. It was decided that the way the Competition are run on the Vet Day be left up to the Host Club.

- Secretary asked Delegates if they wanted the "Affiliation NRVGA" Cards printed again for 2019. There was unanimous agreement YES. It was noted that only three Clubs - Club Banora, Ocean Shores and Murwillumbah have Plastic Cards from their parent Club with the word Veterans on them for proof of membership.
- Reminder from Treasurer that Fees will be increased to \$7.50 per player as from 1
 October 2018. This has been advertised and reminders sent out to all Clubs for the
 past 18 months. The \$\$\$ increase is in line with the NSWVGA Registration Fee
 increase effective 1 October 2018
- There are no FREE Membership to NRVGA irrespective if Clubs offer FREE Membership to their Life Members or the OBE's (over eighties). That is there inhouse decision. Every member must be registered with NRVGA and affiliated payment sent to NSWVGA.
- A question was asked if Bonalbo could be included in our Veteran open Days. The
 Secretary stated that Bonalbo Members could play in Open days as Visitors as long
 as they are Veterans affiliated with NSWVGA. If Bonalbo wanted to affiliate itself
 with NRVGA, they would have to seek permission from NSWVGA and go through the
 regular process for joining a Group (as did Pottsville and Grafton).
- Apologies have been pre-sent for our AGM on 12 October at Byron Bay from our two Councillors. Both will be 'On Duty' for NSWVGA and away from this area.

John Watt thanked Delegates for attending and invited them to the Main Area for some Nibbles, and a safe journey home.
