Mi Club Public web site. Stu is concreating on the Public Web site first. Stu advised the meeting that the public web site should be up and running by end of March 2020. Secretary to send out an email to all Group Secretaries requesting an update list of the details for their group.

Web Coordinators Report

Generally a quiet period for the website due to the break between years for the WOG activities. Main activity has been Contact changes and membership updating. It is interesting to note that there are;

860 without any renewal date 397 with 2018 as a renewal date 7644 with 2019 as a renewal date 6803 with 2020 as a renewal date 18 with 2021 as a renewal date 1 with 2023 as a renewal date 2 with 2024 as a renewal date 1 with 2025 as a renewal date

So, the total of 15727 in the database may not reflect the true financial membership. Treasurer David would be able to confirm how many have actually paid.

There would be a few with the 2019 renewal date that have not renewed in 2020 yet. But the 1257 members prior to 2019 may not be part of the valid membership. Therefore, it is recommended that Group Secretaries be required to formally acknowledge that their membership is up to date.

Barry and I believe that most Groups/clubs struggle with maintaining their membership lists for the NSWVGA. It has been suggested that they use the NSWVGA database as their membership database. This is similar to what Paul Horton had set up. It is important for the revamp database does its best to accommodate clubs' requirements. Global updating is essential.

Since the last meeting MiClub have advised NSWVGA that they are ready to conduct online training for the new site. Due to absences and Christmas/New Year [add the bushfires] this was deferred. Peter and I were given access to work through the manual prior to actual training. I have not as yet been able to spend much time. Although it does straight forward. It is now important that we get this training completed to get the site functioning. Council members will also need to be trained.

Once we are ready to go live I will work with Barry to wind back the functions of the current site to membership management only. It is intended to slowly work through future needs in consultation with Group Secretaries. The need to develop a new membership site I do not see as

urgent as we can continue with existing arrangement as the Public site is our priority.
