I hope everyone is in good health as we head into the Championship Events.

The Masters Championship is at Kyogle on Tuesday 18 October 2022. Entries must be emailed to Ray Kent at rken4251@bigpond.net.au by 5:00pm Tuesday 11 October. The Draw will be done on Tuesday Night.

The AGE Criteria is that participants MUST have turned 70 years old as at 1 June 2022
The PLAYING Criteria is that 3 (THREE) Veteran Open Days must have been played since 2nd

End Of Financial Year ...

I will email your NEW UPDATED LIST along with AN INVOICE for Monies owing. I have colour coded any members who have joined and have been paid for and Money received in <u>August</u> or <u>September 2022.</u> You will not have to pay for these a second time.

Please then remit by Direct Deposit the amount shown on the Invoice, <u>preferably before the end of October</u>, so that I can Register and Pay Affiliation Fees to NSWVGA.
