## **Program Coordinator's Report:**

#### **December 2022 AGM Meeting Program Report**

#### **Overview**

This year's program has completed with some events cancelled, others completed though affected by rain and others were lucky enough to complete without incident.

#### **Trial Events**

Trial events were held at Boggabri and Glen Innes with further trials to be held at Muree (Raymond Terrace) and Harden.

Boggabri went very well, and they will go ahead in 2023 with a two-day event between Tamworth and Narrabri.

Glen Innes, although affected by rain and bad weather completed their week and as TD Ken Kempton summarised, they learnt a lot and were appreciative of advice given by councillors Peter Taylor and Jim Shadlow.

In 2023 we have trials at Muree in May and Harden in the first week of November.

## 2023 Program

The program is already in full swing with nomination packs posted on the web for most early events.

With Gerry Cox stepping down at the end of this year we need to have someone from the Southern region step up and take the reigns for the Mixed Championships at Wagga.

Also, Walcha will host the Sand Green Mixed Championships after this event has been held at Grenfell for several years and I think the least we could do to show our appreciation to the two key figures that ran this event so well during this time. I refer to Shirley and Peter Mawhinney. A Certificate of Appreciation should be forwarded to them, or present same at a Vets event held at Grenfell over the next months. Maybe someone attending Cootamundra could look at this.

Once again it is very important that our councillors are visible on the ground and attend weeks of golf where possible. I understand councillors are repeatedly bombarded with questions not only at the week's golf but also at happy hours, in the showers and even in the streets on days off BUT this is part of what a councillor is there for.

#### 2024 Program

This year we got to version 9 of the Draft Program, but I am happy to report that all Tournament Directors are happy with their times and the information on the Draft is correct. It is an attachment to this report.

#### The major changes with 2024 are:

New England and Northwest are in reverse as far as dates are concerned and this will allow events in the New England region to be held in early April and Central West events to be held in the late April/early May. Easter has been taken out of the equation.

Mid North Coast and Northern Rivers events will commence in late July at Maclean with Sawtell following Yamba and then to Nambucca Heads then onto South West Rocks. This removes any clash with school holidays in the Mid North Coast area.

#### **AVGU AGM**

I attended the AGM along with Aileen

I was expecting a lot of discussion on events and changes effecting Veteran's golf throughout Australia but most discussion centred on their championships.

One thing that was resolved was handicap limits for AVGU events. It was agreed that the maximum handicaps would be 36 for men and 45 for ladies.

The age limits for players were discussed. The representative from South Australia, Brian Nankarvil and our past president Ian had prepared a paper for discussion in 2021 that included age limits. They recommended the same as NSW, 55 years for all. All agreed with this except Queensland who had no knowledge of the paper and will keep with ladies 50 years and above until officially notified otherwise.

The new Secretary/Treasurer has now included our Treasurer Dick and President Les in the AVGU Dropbox.

#### **Conclusion**

Next year will be my last as Program Co Ordinator. I feel that 5 years is enough for one discipline and will look for other areas within the Council for a new challenge.

## WEBSITE REPORT: NSWVGA WEBSITE REPORT - DEC 22

## 1. New Membership Register

This has been a very frustrating time. New versions of the system have been received every 1-2 weeks for the last 6 months, each one seeming to be 'almost ready', only to find some minor problems in each.

Because of the difficulties experienced creating the correct formats for the Bulk Enquiry and Bulk Update functions and interpreting the results, I have created Excel templates which lead the user through these functions.

The system is currently operating with a test version of the database.

When the Membership Register is finally clear of all critical problems, the database will be replaced with a clean copy derived from the current (old) Register and the new Register can be opened for use

Users can be brought on progressively – any residual updates to the old Register will be mirrored on the new register.

We need to contact each Group Secretary (and each Directly Affiliated Club Secretary) individually to check how they currently maintain their records and how many users require access to the new register. At the same time, each GS/Cs should be asked to confirm the contact details for their Group on the public website.

Action: Identify a team to contact each GS/CS. I suggest that 2 people are required.

#### 2. Membership tracking

There have been a number of comments regarding the group affiliations of members.

In the new Membership Register, we are keeping a record of every renewal, not just the current membership status. For each renewal we keep the following data:

- User who entered the renewal
- Date entered
- Year valid
- Date paid
- Affiliation Group

Identifying the User means that we can generate lists of what monies should have been received from whom for what and when.

The Affiliation Group is set by the User. In the normal case of a member joining through their local Group, this would be set to that Group. Where a member joins or renews through some other channel - e.g. at a tournament – the Affiliation Group may be set to 99 (None).

The Affiliation Group for a member may change from year to year.

The Affiliation Group can be used to accurately generate membership statistics by Group etc.

#### 3. Public website

The public website is now running smoothly, but it is regrettable that there still seem to be many members who appear to be unaware of it.

There are many Group Secretaries and Tournament Directors who are diligent in checking their information and notifying us of changes. However, there are regularly instances of GSs or TDs being unaware of what is required. I have proposed above that GSs should be contacted.

I propose that each TD should be contacted individually (say) 6 months before their event to check whether they understand the requirements and to see if they need any assistance.

Action: Allocate responsibility for contacting TDs.

Gerry Cox has been doing a great job of handling the Results and News posts. We should have a second person trained up as a back-up. This person could also take over the updating of the Program and the Groups and Clubs page.

Action: Identify second person to assist with public website updating.

#### 4. Other technical administration

There are a number of other technical duties that I currently handle, listed in the paper circulated to Councillors before the last meeting. Many of these require detailed technical knowledge. I would like to identify someone who would be able to act as a back-up for me.

## APPLICATION PATERSON GOLF CLUB LTD APPLICATION NUMBER ECSAP-22/23-00102

The Paterson Golf Club, from very humble beginnings during the course of WW2, has developed into a very attractive and popular nine hole golf course that is now enjoyed by some 260 plus members, generally resident within 30 kms of the village of Paterson NSW. The Club's website <a href="https://www.patersongolfclub.com">https://www.patersongolfclub.com</a> provides a history if its inception, construction, fulfilment, and present position for your information. The Club is a not-for-profit community sporting facility, it does not have a liquor licence, nor any gaming facilities to support its financial operations.

This year, the Paterson Golf Club, and the village of Paterson, were severely impacted due to inclement weather conditions experienced during the months of January through July, when an excess of 1mtr rain was recorded in the area.

Recently the NSW Office of Sport announced the availability of grants under the Sport Infrastructure Recovery Fund, whereby Sporting facilities situated within approved LGA's, effected by the weather and flooding during 2022, might be able to apply for assistance in the repair, restoration, and betterment of directly damaged local community sport facilities. Paterson Golf Club is situated within the Dungog LGA, an approved LGA under the grant guidelines and has been severely affected by those weather conditions experienced during 2022.

Grants under this Sport Infrastructure Recovery Programme opened on 3<sup>rd</sup> November 2022 and close at 2.00pm Friday 9<sup>th</sup> December 2022.

Although the Paterson Golf Club was not impacted by flood inundation, the effect of 1m rain over the course of 7 months did result in significant damage to our earthen pathways, fairways, flora and fauna. The Club was also required to suspend all playing and competitive competition activity for a period of three months due to the inaccessibility of various areas of the golf course because of the continuing inclement weather and security concerns for players and the maintaince of the golf course.

To assist with the repair and betterment of movement in and around the Paterson Golf Club, we wish to make an application to the NSW Office of Sport, Sport Infrastructure Recovery Fund, for a grant of \$250,000-00 that would see the present earthen paths in and around the Paterson Golf Course, replaced with concrete paths 1.5Mtr wide covering an area of approx. 5Kms in length. This request

would allow for the effective weather proofing our Golf Course, ensure that course maintaince via the availability of access for plant and equipment to all areas of the golf course during inclement weather conditions, and make the game more accessible to those persons with a disability and who are dependent upon mobility devices to enjoy the game of golf.
