- Motion for Change of Banking Institutions from ANZ

At our AGM in 2023, Treasurer Ray Kent outlined the current situation with our banking institution at ANZ and the need to be reassess it in regard, to, Interest and Charges being made from November 2023 to our Working Account.

A motion was put ..."NRVGA withdraw our finances from ANZ and look for another

Banking Institution which will pay a more reasonable Interest Rate and has reduced Fees"

Moved Doug Trigg (Byron Bay / Seconded Rod Ellis (Maclean)

The Motion was put and Delegates voted ... Motion CARRIED (Unanimously)

ACTION to be taken ... Treasurer, Ray Kent will begin looking into Banking Institutions that would provide better returns for our everyday account and Term Deposit of \$6,000.00. This will be reported back to Delegates at the Half Yearly general Meeting in June 2024

Treasurer's Financial Report moved by Ray / Seconded John Swan (Ballina)

CARRIED by all Delegates

Report to Delegates by Treasurer

Ray stated that he had researched a number of Banking and Investment Institutions to determine which one(s) would provide NRVGA with a better product in regard to Interest and Fees than our current provider.

Ray also stated that he had not rolled over our current \$6,000.00 Term Deposit with ANZ as this matured on 18 June 2024 (before our Meeting Date) and had closed the Term Deposit with no Exit Fee. The funds had been deposited into our ANZ Working Account.

Ray researched Commonwealth Bank, Southern Cross Credit Union, WestPac, LaTrobe Australian Credit Fund and Bendigo Bank.

These were discussed and the following Motions were voted upon ...

MOTION 1 ... That the original amount of \$6,000.00 be invested with Latrobe Australian Credit Fund for 12 months at 6.75%p.a. in the name of Northern Rivers Veteran Golfers Association and known as NRVGA

Moved Ray Kent, / Seconded Rod Ellis ... CARRIED

MOTION 2 ... That NRVGA open a Transaction Account and a Sandhurst Cash Common Fund Account (net of all fees and costs) having a Rate of Return at 3.85%p.a. with Bendigo Bank, Tugun in the name of Northern Rivers Veteran Golfers Association and known as NRVGA

Moved Ray Kent, / Seconded John Swan ... CARRIED Unanimously

ACTION #1: Secretary Ray Kent and President John Lowe together attend Bendigo Bank, Tugun, on a date to be fixed, to **Open an Account** with **Bendigo Bank** *in the name of* **Northern Rivers Veteran Golfers Association** and known as NRVGA. Both Executives to be signatures on the Account with either 'one to sign'.

Once this is established, all funds from ANZ are to be transferred into this Account and the Banking Details of which are to be broadcast to all Secretaries and/or Treasurers for their updating of Banking Details presently held

ACTION #2: Once this working account is set up, \$6,000 will be withdrawn to be invested with the **Investment Fund set up** with **Latrobe Australian Credit Fund** in the name of **Northern Rivers Veteran Golfers Association** and known as NRVGA. Rod Ellis will assist in helping to set this up.

- This was discussed and John Lowe(President) said that he would ensure that all records needed to be kept up-to-date would be. Ray to liaise with John
- All payments to Clubs for upcoming Veteran Open Days will be forwarded to the respective Host Clubs before the end of the July. Any Club that has to cancel due to external factors are to return funds to NRVGA (New Account)
- Ray to contact our Volunteer Auditor to discuss End Of Year Financial Report.
- Ray can still be contacted overseas via email during this period.
